



DSCJ – Deutscher Sport Club Johannesburg ("DSCJ" or "The Club") – at a glance

Club Set-Up, Teams & Coaches in 2025

- DSCJ is a sports club that currently only runs a soccer branch.
- The club is a member of the Rand Central League Football Association ("RCLFA"), which operates under the umbrella of South African Football Association (SAFA) Johannesburg. We participate in competitive league matches and various cup tournaments organised by the RCLFA.
- The DSCJ is run by an elected board and is independent from the school.
- However, we co-operate closely with the school and are allowed to use the school's facilities.
- DSCJ cooperates with Jozi Talent (Pty) Ltd, a reputable South African football company ("the Co-operation Partner").

- Summer: Saturday training is held for all ages from 09:00 – 11:00. Winter: Saturday training is at 10:00 - 12:00, except when league matches take place. League matches are on Saturdays or Sundays, depending on the age group. The league matches usually start after the Easter holidays & end in October or around the Spring holidays.

Venue

Training is held at the DSJ sports ground or the DSJ Turnhalle, with permission from the DSJ management.

The Annual Fees and Kit Cost

The annual fee for players is R6, 000 for players who wish to compete in league matches (includes league fees) or R4,000 for training sessions only. Training sessions run throughout the year (except during school holidays). Fees are also used for coach'es salaries, referees, and equipment. These fees do not include the DSCJ football kit, which is required by all league players to be worn at matches. The cost of the kit, which consists of a shirt, a pair of shorts and socks is R650/kit. The 2024 kit will be used for the 2025 season. No new kit will be required for those who have purchased a kit in 2024.

Photos and ID numbers

The player's South African ID number (or nationality and passport number) and current colour photo are required for all league players. Players who have played in the league previously do not need to submit these, unless details have changed, or an updated photo is required.
